SECTION 4) FIRST-AID MEASURES

Inhalation

Remove source of exposure or move person to fresh air and keep comfortable for breathing. If experiencing respiratory symptoms: Call a POISON CENTER/doctor.

Eye Contact

Seek medical attention immediately. Rinse eyes cautiously with lukewarm, gently flowing water for several minutes, while holding the eyelids open. Remove contact lenses, if present and easy to do. Continue rinsing for a duration of 15-20 minutes or until medical aid is available.

Skin Contact

SECTION 5) FIRE-FIGHTING MEASURES

Suitable Extinguishing Media

SECTION 6) ACCIDENTAL RELEASE MEASURES

Emergency Procedure

Isolate hazard area and keep unauthorized personnel away. Stay uphill and/or upstream. Do not touch damaged containers or spilled materials unless wearing appropriate protective clothing. Ventilate closed spaces before entering.

Recommended Equipment

Wear chemical protective clothing.

Personal Precautions

Avoid breathing vapor or mist. Avoid contact with skin, eye or clothing.

Environmental Precautions

Stop spill/release if it can be done safely. Prevent spilled material from entering sewers, storm drains, other unauthorized drainage systems and natural waterways by using sand, earth, or other appropriate barriers. Dike far ahead of liquid spill for later disposal.

Methods and Materials for Containment and Cleaning up

Absorb Liquids in vermiculite, dry sand, earth, or similar inert material and deposit in sealed containers for disposal.

SECTION 7) HANDLING AND STORAGE

General

Do not use on extensive surface areas in premises where there are occupants. Do not use empty container before they have been cleaned. Before making transfer operations, assure that there are not any incompatible material residuals in the containers. Contaminated clothing should be changed before entering eating areas. Use pneumatic and/or mechanical systems for bulk transfer of the substance. Use exhaust ventilation and/or dust collecting filters for bulk transfer and storage. Use approved respiratory protection when handling. Keep bulk of materials out of sewer drains. Wash hands after use. Do not get in eyes, on skin or on clothing. Avoid formation of dust and aerosols. Provide appropriate exhaust ventilation at places where dust is formed. Use good personal hygiene practices. Eating, drinking and smoking in work areas is prohibited. Remove contaminated clothing and protective equipment before entering eating areas. Eyewash stations and showers should be available in areas where this material is used and stored.
